When you return the key within 24 hours from receiving it you will be refunded your \$35.00 deposit. If you don't return the key in the 24 hour period to where you received the key or lose the key you will forfeit the deposit, but will become a current, active member with all rights and privileges thereof for the remainder of the current riding year (December 31 of same).

Release/Rules

The following must be read and signed by all persons who enter and ride at the Casper Dirt Riders facility. By signing, you agree that you have read and understand the rules and liability release, and further to abide by all Casper Dirt Riders rules written and unwritten.

As a person at any Casper Dirt Riders facility or event, I agree to conform to and comply with all laws, rules, regulations and decisions of the facility or event. It is understood and agreed that I the undersigned, am entering this facility or event of my own free will and that I am [at least 18 years if age or have [written] consent or my parent(s) or legal guardian to be here. I further agree to hold blameless Casper Dirt Riders and its board members, the City of Casper, sponsors, local management, property owners or lessees, and anybody else connected to this facility or event for any loss or injury to myself or property and assume full responsibility for any loss to myself or property in which I may become involved by reason of participation herein.

Failure to abide by the rules set forth will result in loss of the day pass, expulsion from the CDR premises, and suspension from re-entry to the facility. Fines and/or legal action may be pursued.

- **Any person not a current CDR member shall fill out a day pass form regardless of age.**
- A current day pass application & liability release must be on file with the CDR before anyone may be present at a CDR facility and **will be active for 24 hrs. from the time this form is signed by the rider. Failure to return the key in said time will** forfeit the \$35 deposit but will be accepted as a current, active member with all rights and privileges thereof for the remainder of the current riding year (December 31 of same). **(ALL MEMBERSHIP RULES AND REGULATIONS SHALL APPLY).**
- Gates must be locked behind you after entering and leaving the facility.
- Loaning out and/or duplicating CDR keys will result in suspension and loss of privileges and fines up to \$250.00 set forth by the Casper Dirt Riders AND the City of Casper
- **No Day Passer shall let a non-member or non-day passer ride at a CDR facility.**
- Hours of the Prickly Pear MX track are dawn to dusk. The track will be closed to all riders for track preparation for no less than one week prior to a scheduled event.
- Riders are required to wear proper riding apparel, including helmets and goggles.
- Absolutely no riding outside of fenced property.
- Motorcycles & ATV's must be in safe working order, including working front & rear brakes and have operable silencers
- Harassment of any individual at a CDR facility will result in expulsion from the track and loss of the Day Pass privileges.
- No rider shall be under the influence of alcohol or drugs.
